

Remeo acquires Delete Ympäristöpalvelut Oy

Remeo has made an agreement to purchase the entire share capital of Delete Ympäristöpalvelut Oy. Through the acquisition, Remeo will implement its growth strategy by strengthening and diversifying its nationwide operations in Finland. The acquisition will also further expand and reinforce construction and demolition waste treatment operations.

Remeo has agreed to purchase the entire share capital of the environmental maintenance company Delete Ympäristöpalvelut Oy. The transaction is scheduled to take place on June 29, 2022. With the acquisition, Delete Ympäristöpalvelut Oy's entire business operations will be transferred to Remeo Group.

"The acquisition of Delete Ympäristöpalvelut Oy is part of Remeo's growth strategy and will strengthen our geographical coverage and diversify our service offering. With the acquisition, we will also strengthen our already strong construction and demolition waste management operations," says **Johan Mild**, CEO of Remeo.

With the acquisition, Delete Ympäristöpalvelut Oy will become part of the strong and solvent industrial palyer Remeo Group, which is a European pioneer in material recycling and one of the most significant companies in the environmental maintenance sector in Finland.

"With the transaction, we will offer Delete's customers a wider reception network and we will diversify and improve our service offering. Our treatment plant, opened in Vantaa last year, is the most advanced in Europe. The facility processes corporate waste to pure recyclable materials, while increasing the recycling rate of Delete's customers. For Remeo's existing customers, we will offer new services and wider regional coverage with the purchase. We are also looking forward to welcoming Delete staff as a part of the Remeo team," Johan Mild sums up.

Delete's processing facilities will come part of Remeo's comprehensive network of processing facilities in Finland and thus increasing Remeo's capacity to receive and process materials. Emission reductions will be achieved by optimizing logistics as the network of processing facilities grows. Especially the Helsinki metropolitan area and the Pirkanmaa region will benefit from the purchase as operations in the areas will increase.
